

# NRA BASIC PISTOL SAFETY COURSE

Get hands-on experience in pistol shooting techniques in this ten (10) hour course. You will learn the fundamentals of safe gun handling as well as the Hawaii and Federal laws pertaining to firearms and ammunitions. Anyone over the age of 12 may apply.

To obtain a "Permit to Acquire" for Hand Guns in Hawaii you must complete either a NRA Firearms or Personal Safety class or a Hawaii Hunter Safety Class. Graduates of the NRA Basic Pistol Safety Course will receive a notarized certificate to use when registering their firearms.

The course will be conducted over two days, Thursday evening 5:00 PM to 9:30 PM and the following Saturday 8 AM to 4 PM at the Ukumehame Range and Classroom. Ukumehame Range is located just mauka off Honoapiilani Hwy (#30) approximately three miles east of Olowalu. The course fee is \$60.00 which includes a copy of the classroom textbook and the use of firearms and ammunition. All materials, firearms and ammunition will be furnished by Valley Isle Sport Shooters. The course will be offered on the following dates in 2012.
